FINANCIAL AID APPEAL PROCESS (FAA)

According to federal regulations, students who are denied financial aid based on unsatisfactory academic progress may appeal if one of the following applies:

- 1. Death or serious illness of an immediate family member.
- 2. Serious illness or injury to the student or to a dependent child;
- 3. or other traumatic life-altering events that may be considered by the Appeals Committee (natural disaster, incarceration, serious domestic problem, etc.).
- 4. Special circumstances that the student would like for the committee to consider (change of degree program, change of grade(s), academic amnesty, etc.).

Financial aid appeal requests must be submitted in writing to the Financial Aid Appeals Committee in the Office of the Vice Chancellor for Administration & Finance. **The final day to submit an appeal is the first day of class**. Appeals may not be accepted after this date. **Submission of an appeal does not guarantee financial aid reinstatement**. WHAT SHOULD YOU DO?

- 1. Obtain a Financial Aid Appeal Petition Form from the Office of the Vice Chancellor for Administration & Finance, Administration Building, Suite 301 or online.
- 2. Complete the Financial Aid Appeal Petition Form.
- 3. Complete letter (typed) stating the reason(s) for not maintaining satisfactory academic progress as outlined in the Satisfactory Academic Progress Policy and reason(s) you feel your financial aid eligibility should be reinstated. **Documentation supporting the reason(s) stated in your letter must be included.**
- 4. Obtain a copy of your **updated** transcript from the Office of Records, Bashful Administration Building, Room 212. There is no charge for the transcript request.
- 5. Return the completed petition form, typed appeal letter, documents, transcript(s) request, and academic action plan to Bashful Administration Building, Suite 301, Office of the Vice Chancellor for Administration & Finance.
- 6. FAAs are accepted July 1st for Fall semester appeals and November 15th for Spring semester appeals. There are no Financial Aid Appeals for Summer.
