Students in our teacher preparation program are required to enroll in courses [Diverse Learners (focuses on working with students with disabilities,

students from low-income families, students from different ethnic backgrounds, and limited-English proficiency students) and Multicultural Education (focuses on working with students from diverse cultural and religious backgrounds)] which specifically address these concerns. Additionally, they are required to complete part of their early field experiences in these settings so that they have the advantage of experience in the differing environments, as many of our prospective teachers will be placed in urban schools.
