Postgraduate candidates must have at least a bachelor's degree in a field of study other than education from an accredited institution, must take and pass Praxis I: Reading, Writing, and Mathematics and Praxis II--Content Knowledge (0014) prior to being admitted. Candidates must also have a GPA of at least a 2.2 overall and at least a 2.5 GPA on the last 60 hours attempted. While in the program, the candidate must maintain a minimum of a 2.5 on all coursework being taken. Exceptions to Praxis I: Reading, Writing, and Mathematics as a prerequisite are if the postgraduate candidate has a Master's Degree, earned an ACT Composite score of at least 22, or an SAT Composite score of at least 1030.

Students in our teacher preparation program are required to enroll in courses [Diverse Learners (focuses on working with students with disabilities,

students from low-income families, students from different ethnic backgrounds, and limited-English proficiency students) and Multicultural Education (focuses on working with students from diverse cultural and religious backgrounds)] which specifically address these concerns. Additionally, they are required to complete part of their early field experiences in these settings so that they may have the advantage of experience in the differing environments, as many of our prospective teachers will be placed in urban schools. During Internship, they are further required to demonstrate their ability to work with students from different backgrounds or with disabilities, and are rated on such during their observations. Finally, members of the school community (principals) are frequently invited in as guest lectures to speak with the prospective teachers to enhance the theory and supplement the practice they receive in the university classroom. Additionally, incoming candidates that do not have at least one semester of observed and evaluated teaching experience must enroll in an 80-hour workshop that addresses classroom management, classroom environment, lesson design, and lesson delivery.

Students in Diverse Learners are taught how to implement IEPs, how to assist in writing IEPs, and are presented scenarios so that they work as a team in preparing IEPs for students who are working from IEPs.

Prior to enrolling in the alternative certification program, intended candidates must take and pass Praxis I, Reading, Writing, and Mathematics and Praxis II 0014. Exceptions to taking the Praxis I series of tests are if the intended candidate holds a Master's degree or achieved a 22 or higher on the ACT. Additionally, the intended candidate must present three letters of recommendation, have a background check completed, provide a resume, a philosophy regarding education in general and his/her role in pursuing a teaching certification, and go through an interview process. During the interview faculty assess dispositions of the intended candidate. The alternative certification program is 33 hours and can be completed in two years. Additionally, alternative education candidates must complete an intensive 80-hour workshop if they have no teaching experience. This workshop addresses classroom environment, classroom discipline, lesson design, and lesson delivery. This 80-hour workshop is a requirement of the state.
