- Must be a senior entering Field III
- Concentration: Children Youth and Family (CYF) or Health/ Mental Health (H/MH)
- Must maintain good academic standing throughout the program with a 3.0 GPA
- \$9,500 financial scholarship for educational expense to include tuition and fees for MSW scholars

If you do not have prior experience, please explain your motivation for working with this population, children and families.
- 4) Please reflect on your own experiences and commitment to culturally competent social work practice with clients who are not of your own racial, ethnic, cultural identification, political, sexual orientation or religious beliefs. How do you see your own values and personal bias potentially impacting your practice?
- 5) Many clients who utilize the services of DCFS programs are affected by poverty, mental illness, developmental disorders, addictions, etc. In what ways are you prepared to interact with families with these challenges?
- 6) What strengths will you bring to the placement?
- 7) Briefly describe your beliefs as to what is the most powerful influence in a child's life.
- 8) Describe your short-term and long-term professional goals and how you believe this training in child welfare can assist you in achieving these goals.
